- We feed dry cat food and supplement with pouched food. You are welcome to supply treats or specialized food. We will gladly feed these. If your cat is on a special diet, please supply enough food for your cat's entire stay.
- You may bring bedding for your cat, but please mark it clearly. We have plenty blankets and igloos.
- You can leave your carrier with us, so that you don't have to remember it when returning from your travels. Please mark it clearly.
- Your cat's last inoculations must not be older than 12 months. Please remember your vet booklet.
- Page 2 is a map to show our facilities in Pretoria East.
- Page 3 is the contract you will be required to sign. Please read it through.

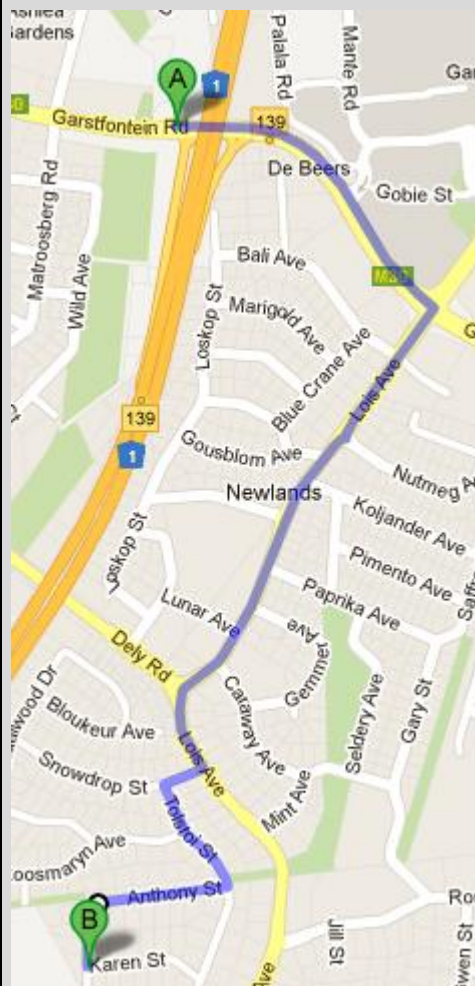

## WHEREAS

the Owner is the legal and beneficial owner of the animal, as detailed in form hereto (hereinafter referred to as the MEMORANDUM OF AGREEMENT) ENTERED INTO BY AND BETWEEN The Cattery AND The Owner

**AND WHEREAS** the OWNER wishes to board the cat for the agreed time:

**NOW THEREFORE THE PARTIES AGREE AS FOLLOWS:**

## DURATION

This agreement shall come into operation on the day of arrival (Annexure A), upon payment of the full boarding fee, and shall end on the DAY OF DEPARTURE, unless further days are booked and paid by the time this agreement ends.

## RISK, FEES AND EXPENSES

- The boarding fees are payable in full in advance before the animal is accepted for boarding.
- In addition to the boarding fee, the OWNER shall also be responsible for the veterinarian costs, as deemed necessary

The Cattery and cleared with the OWNER, unless it is deemed an emergency.

- All risk in and rights to the ANIMAL shall remain with the OWNER.
- ***In the event that the ANIMAL shall die of natural causes while the subject of this agreement, neither party shall have any claim against the other.***
- The ANIMAL may not be re-located without the Owner's prior permission.
- Any day(s) that the animal stays longer than the agreed upon date at the Cattery, the OWNER is responsible for the additional fees. The Cattery reserves the right to dispose of the animal as they see fit, after 14 days after day of departure, unless the owner makes alternative arrangements.

## DOMICILIUM

The parties choose their respective "domicilium et executandi" for all purposes under this agreement, including for the purpose of serving notices or legal processes in connection with or arising from this agreement, or the cancellation thereof, the address on the booking form.

## JURISDICTION

The parties hereto consent to the jurisdiction of the Magistrate's Court irrespective of the quantum involved in any action that may arise from this agreement.

## WHOLE AGREEMENT

This agreement constitutes the whole agreement between the parties and no alterations hereto or variations hereof shall be legal and binding unless such alterations and/or variations have been reduced to writing and signed by both parties;

## RELAXATION

No relaxation or indulgence which may be allowed by any party at any time in regard to the other parties' performance of any such parties' obligations of this agreement shall be construed as a waiver of or prejudice the rights of the other party.
